# **Club Kosher Official Tour Participant Agreement**

## **Terms and Conditions:**

**Tour Operator:** Club Kosher/Kismet Travel herein referred to as "Tour Operator" has arranged the vacation package(s) described in website/brochure/flyer/invoice/confirmation.

**Price Includes:** Price includes all items listed in the price guide under "vacations include." Hotel accommodations based on double occupancy, including Glatt Kosher meals, traditional Orthodox Synagogue services, any admissions, sightseeing, entertainment and activities. Visas and documents, tour-guides, excursions, group transportation as indicated, transfers, group flights. Programming, guests, events, entertainment, activities, etc. subject to change.

**Price Does not Include:** Tips, laundry, telephone calls, in-room safes, motorized water sports, and any items and/or services of a personal nature are not included. Price does not include flight deviations or luggage charges that may apply.

**Reservations:** A down-payment of \$1000 per person, as well as a signed Participant's Agreement/Reservation Form, is immediately required to secure your reservation. Balances due 60 days prior to departure. Reservations made within 60 days of departure must be paid in full.

**Cancellation Policy:** Full refund less \$299 office fee per person if you notify us in writing more than 120 days prior to trip. 60-120 days full refund less \$599 fee per person with written cancellation notice. Less than 60 days a cancellation fee of 50 percent of your total bill will be charged/retained. No refunds for no-shows or cancellations made less than 30 days prior to departure. All cancellations must be received in writing, via certified mail with return receipt requested. Trip cancellation insurance/personal travel insurance is available and advisable. Once tour is in progress, there will be no refunds.

**Proof of Citizenship:** U.S. citizens must carry proper proof of citizenship (valid U.S. Passport) and Visa. Non-U.S. citizens should consult their consulate for I.D. Requirements. Citizenship documentation requirements vary by destination and are subject to change without notice. Tour Operator assumes no responsibility for such changes, nor has any responsibility to notify tour participants of such changes. Passengers who are denied boarding or entry for improper or incomplete documentation will receive no refunds.

Tour Operator is not an agent or representative of hotels, airlines, cruise lines, bus companies, and/or owners operators, or contractors (all hereinafter called contractors) providing services in connection with these tours. Additionally, all tickets, receipts, coupons, and vouchers are issued subject to the terms and conditions specified by these Contractors. As agent of the tour participants, Tour Operator is not responsible for any damage, death, injury, or loss resulting from any cause. By accepting these coupons and tickets, or utilizing the services, tour participants agree that neither Tour Operator nor its representative and/or agents shall be liable for any loss, or additional expenses, injury or damage to the tour participants or their belongings or otherwise in connection with any Tour Operator, including breakdowns in equipment, strikes, acts of God, fire, act of government or other authorities, wars declared or not, riots, theft, pilferage, epidemics, quarantines, medical/customs regulations, delays or cancellations of, or change in, itinerary or schedules, etc. Tour Operator reserves the right to withdraw and/or to cancel a tour or to make changes in the itinerary. If Tour Operator cancels the tour, it shall have no responsibility beyond refund or monies paid to the Tour Operator by tour participant(s).

The parties consent to the jurisdiction of the courts of the State of New York for the purpose of enforcing any determination of the Beth Din, and for enforcing this arbitration clause. Any arbitration with respect to a dispute relating to the travel envisaged by this document or the confirmation shall be commenced within 60 days of the first day of the tour.
